## SUMMARY OF PROCEEDINGS OF THE MEETING OF CEHELE QUITY SHAREHOLDERS OF VIPUL ORGANICS LIMITED CONVENED AND HELD PURSUANT TO THE ORDER OF THE HON'BLE NATIONAL COMPANY LAW TRIBUNAL, MUMBAI BENCH, MUMBAI

The meeting of Equity Shareholders of Vipul Organics Limited ('Company') was convened and held pursuant to the order of the Hon'ble National Company Law Tribunal ("NCLT"), Mumbai Bench, Mumbai dated 21<sup>st</sup> August, 2019, passed in the matter of Scheme of Amalgamation of Efferchem Private Limited (Transferor Company) and Vipul Organics Limited (Transferee Company) under Section 230 – 232 of the Companies Act, 2013, on Monday, 30<sup>th</sup> September, 2019 at 4:30 P.M. at Hotel Karl Residency, 36, Lalubhai Park Road, Andheri (West), Mumbai-400058.

Ms. Yogita Mundhra, Company Secretary & Compliance Officer of the Company informed about the convening of the meeting and also informed that Mr. Vipul P. Shah, Managing Director of the Company has been appointed as Chairperson of the meeting by the Hon'ble National Company Law Tribunal, Mumbai Bench (NCLT) vide order dated 21<sup>st</sup> August, 2019. Accordingly, Mr. Vipul P. Shah presided over the meeting.

The requisite quorum being present, the Chairman called the meeting to order, All the Directors of the Company, except Mr. Jagdeep Mehta, attended the Meeting.

The Notice of the Meeting, the Explanatory Statement under Sections 230(3), 232(2) and 102 of the Companies Act, 2013 read with the Rules framed thereunder and the Scheme, had already been dispatched to all the Members. With the consent of the Members, the Notice convening the Meeting was taken as read.

The Chairman then provided a brief background and rationale for the Scheme.

The Chairman informed the Members that as required under the Companies Act, 2013 read with the Companies (Compromises, Arrangements and Amalgamations) Rules 2016 and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had provided its Shareholders the facility to cast their vote through remote e-voting for a period of 30 days i.e. from Saturday, 31<sup>st</sup> August, 2019 (9.00 A.M. till Sunday, 29<sup>th</sup> September, 2019 (5.00 P.M.). He also informed the meeting that the facility of electronic voting is also being made available at the venue of the Meeting i.e. through Tab - based e-voting (using TABLET device) administered by Central Depository Services (India) Limited (CDSL) for the Members who had earlier not exercised their vote through remote e-voting.

The Chairman further informed the Members that Hon'ble National Company Law Tribunal, Mumbai Bench, Mumbai has appointed CS Manish Baldeva (FCS No. 11062) of M/s. M Baldeva Associates, Company Secretaries as Scrutinizer to supervise the remote e-voting and voting at the Meeting to be conducted in fair and transparent manner.

The Chairman then invited the Members to express their views, ask questions and seek clarifications on the Scheme.

The Chairman thanked the Members for attending and participating in the meeting. He informed the Members that the consolidated voting results would be made available on the website of the Company viz. <u>www.vipulorganics.com</u> and the website of CDSL viz. <u>https://evotingindia.com</u>, within 48 hours of the
