उदगीर शहरात हिंदू देवतांविषयी आक्षेपाई वक्तव्य, संबंधितां विरोधात कठोर कारवाईची मागणी

लातूर, दि. १३: उदगीर शहरात हिंदू देवतांविषयी आक्षेपाई वक्तव्य केल्याचा आरोप करत संबंधित व्यक्तीविरोधात कठोर कारवाईची मागणी करण्यात आली आहे. भारतीय जनता युवा मोर्चा तसेच श्रीमठ प्रतिष्ठानच्या वतीने सीतेश राजेंद्र पाटील यांनी याबाबत पोलीस स्टेशन उदगीर येथे लेखी तक्रार दाखल केली आहे.

तक्रारीनुसार, कालिदास सूर्यवंशी ( रा. अटरगा) नावाच्या व्यक्तीचा एक व्हिडिओ गेल्या काही दिवसांपासून सोशल मीडियावर मोठ्या प्रमाणात व्हायरल होत असून, त्या व्हिडिओमध्ये हिंदू आराध्य देव शिव आणि लक्ष्मण यांच्याबाबत आक्षेपाई व अपमानास्पद वक्तव्य करण्यात आल्याचा आरोप आहे. या प्रकारामुळे हिंदू समाजाच्या धार्मिक भावना दुखावल्या गेल्या असून समाजात तेढ निर्माण होण्याची शक्यता व्यक्त करण्यात आली आहे.

सदर व्हिडिओ जाणीवपूर्वक तयार करून प्रसारित करण्यात आल्याचा आरोप तक्रारीत करण्यात आला आहे. तसेच, व्हिडिओ वित्तिकरणामुळे उपस्थित असलेल्या काही व्यक्तींनी टाळ्या वाजवून व हसून संबंधित व्यक्तीस प्रोत्साहन दिल्याचे नमूद करण्यात आले आहे. त्यामुळे मुख्य आरोपीसह त्याला प्रोत्साहन देणाऱ्या इतर संबंधित व्यक्तींवरही सहआरोपी म्हणून गुन्हा दाखल करावा, अशी मागणी करण्यात आली आहे.

तक्रारीत भारतीय दंड संहिता तसेच माहिती तंत्रज्ञान कायदांतर्गत संबंधित कलम नुसार गुन्हा नोंदवून तात्काळ अटक करण्यात यावी, तसेच सोशल मीडियावरील संबंधित व्हिडिओ हटविण्यासाठी तांत्रिक पातळीवर कारवाई करावी, जेणेकरून कायदा व सुव्यवस्थेचा प्रश्न निर्माण होणार नाही, अशी मागणी करण्यात आली आहे. याप्रसंगी भारतीय जनता युवा मोर्चा व श्रीमठ प्रतिष्ठानचे प्राधिकारी व कार्यकर्ते मोठ्या संख्येने उपस्थित होते. दरम्यान, या प्रकरणी पोलीस प्रशासनाकडून पुढील तपास सुरू असल्याची माहिती मिळत आहे.
