The total sale consideration for the aforesaid transaction is INR 8000 lacs subject to adjustments as set out in the BTA. In view of the continuing phased country wide lockdown to minimise the spread of Novel Coronavirus (COVID-19) across the country, both the parties on 11 June 2020 have mutually agreed to further extend the long stop date till 15 July 2020. The Group has successfully completed the sale and transfer of the Business in terms of the BTA, as amended from time to time, on 1
